SIPPs: You cannot use this form to withdraw money from your HL Vantage SIPP. Money held within a SIPP is governed by pensions legislation, which restricts your access to the funds. Please contact our Pensions Helpdesk on **0117 980 9926** for more information.

Junior ISAs: You cannot use this form to withdraw money from a Junior ISA; no withdrawals are permitted until the child reaches 18, at which point the Junior ISA becomes an 'adult' ISA.

If you reduce the level of cash or stock in your account to a value below £50 we will close your account and return the balance to you, less any outstanding fees and our account closure fee of £25 +VAT. If your balance is under £25 +VAT this will be taken as the account closure fee. This fee does not apply to the Vantage Cash ISA.
